FEDERAL HEALTH REFORM UPDATE

As many of you know, this was a busy week on Capitol Hill! Yesterday, Regina Benjamin was unanimously confirmed by the United States Senate to be the next U.S. Surgeon General, and this week, the House of Representatives revealed their chamber's health reform bill.

House

Yesterday, the United States House of Representatives released its next iteration of the health reform bill, the *Affordable Health Care for America Act* (HR 3962). The bill includes a public option favored by more moderate Democrats that would have physicians negotiate their payment rates directly as opposed to tying those rates to Medicare (or Medicare plus five percent). House Democrats aim to take HR 3962 to the chamber floor by next week, with a final vote to occur before Veterans Day (Nov. 11).

According to estimates from the Congressional Budget Office (CBO), HR 3962 will cost \$1.055 trillion between 2010 and 2019 and reduce the federal deficit by \$104 billion. While the bill's gross cost exceeds \$1 trillion, its net cost, after subtracting revenue raised from taxes and fees, is \$894 billion, which is the number House Democrats cited when they unveiled the bill yesterday.

HR 3962 would also expand eligibility for Medicaid to those who earn 150 percent of the federal poverty level (FPL)—about \$16,245 annually for an individual and \$33,075 annually for a family of four. Previous versions of the bill had raised the threshold to 133 percent FPL.

The Academy is still reviewing the House legislation, and will continue to provide updates as additional revisions are made in the coming days.

Some highlights of particular note to children and pediatricians are as follows:

The main Medicaid/Children's Health Insurance Program (CHIP) section of HR 3962 includes many policies that were included in the House's Tri-Committee bill passed earlier this summer, HR 3200. In particular, the following provisions remain in the new legislation:

- An increase in Medicaid payment rates for primary care services to 100 percent of Medicare over three years, with new federal funding.
- Appropriation of \$1.235 billion over five years for a Medicaid medical home demonstration project.
- Significant new investments in the primary care workforce.

Additional highlights of the new House bill, HR 3962, include:

- Automatic Medicaid coverage for all children born in the United States for up to 60 days after birth, with “opt-out” eligibility extended in Medicaid thereafter.
- Expansion of Medicaid eligibility to all legal residents at or below 150 percent FPL. This helps children between 133 percent and 150 percent FPL who would otherwise have lost Medicaid coverage. Children at or below 150 percent FPL are locked into Medicaid with no opportunity to receive affordability credits for their coverage in the exchange, however.
- Extension of dependent coverage on parents/guardians’ insurance to those ages 26 and below.
- A public health insurance option with negotiated payment rates.
- The sunset of CHIP on December 31, 2013.

Last week marked a significant step forward in the Senate’s progress with health reform legislation when the Finance committee passed their health reform bill, which is now being melded with the Health, Education, Labor and Pensions (HELP) bill. Despite previous conjecture to the contrary, the combined health reform bill may still include a public insurance option that states can “opt out” of, or decide not to participate in. Details on the specifics of this public plan are still unclear, and Senate Majority Leader Harry Reid (D-Nev.) continues to conduct meetings with White House officials, Senate Finance Committee Chairman Max Baucus (D-Mont.) and Sen. Chris Dodd (D-Conn.) to finalize Senate health reform legislation.

Sen. Reid has submitted several versions of the bill to the CBO for cost evaluations, which will influence how the final legislation is crafted. Senate leaders are hoping to finalize the Senate compromise legislation and move to the floor as soon as possible. Awaiting these CBO scoring results could delay the timeline for introducing Senate legislation on the floor.
